2) The Management has submitted the self-Certification for Educational Building with Ground + (2) Two Upper Floors with a height of 09.14 Mts., with total Built-up area of 2136.24 S Mts., and stated that, they have provided the following safety Measures.

3) It is suggested to the Management for providing the following Fire Safety Measures keeping in view of Practically, Maintenance and Resilience.

4) The management has stated that, they satisfied with the installation and maintenance of the fire safety equipment working condition in the building and also they declared that no additions or alterations have been made in the building affecting Fire Prevention and Fire Safety Measures including means of escape and that all exits and passages are free from any obstruction.

5) In view of the above, based on the self certification submitted by the Management and also taking into consideration of the larger public interest in the context of the COVID-19 pandemic across the Country, the Renewal of No Objection Certificate is issued to the existing building of M/s Siddhartha Quest (CBSE) School, D.No.6-51, Vatluru Village, Pedapadu(M), Eluru District Ground + (2) Two upper Floors with a height of 09.14 Mts., with total Built - up area of 2136.14 Sq. Mts., for Educational Occupancy.

- 6) The Management shall ensure the following conditions:
- The Management is responsible for all risk involved in case of Fire Accident.
 - This NOC is given based on the information, documents and drawings provided by the applicant. The applicant confirms that the information provided and the documents and drawings submitted are correct. Any deviation noticed will lead to cancellation of NOC without any notice.
 - The permission accorded does not confer any ownership rights. If it is found that the Information furnished is false and fabricated the permission will be revoked at any stage and the applicant will be liable for criminal prosecution as per IPC.


7) It is informed that, the Management is required to maintain the following conditions compulsorily for safety purpose.

1.	All the Fire protection arrangements shall be maintained in good working condition at all times.	The Escape/Exit roots shall not be kept Locked/Blocked or Encroached.	All the occupants must be trained the correct method of operation of the Fire Fighting System installed.
2.	Any loss of life or property due to non-functioning of Fire Safety Measurers and other Installations shall be the responsibility of the management.	All occupants shall be trained to operate the Fire Safety Equipment during Emergency.	Mock Drills should be conducted once in 03 months for intial two years. Thereafter once in every 6 months.
3.	Addition/Alteration, if any in the Building may be verified by Building authority.	Mock Drills should be conducted once in 03 months for intial two years. Thereafter once in every 6 months.	All Security Personal shall be trained to operate the Fire Safety Equipment during Emergency.
4.	This Annual Periodical Renewal Fire Certificate is only from Fire Safety Point of view.	Raise the alarm If the Fire cannot be controlled, Evacuate the area completely at once with nearest Safe Exit.	Attack the Fire using available Fire Equipment only if you feel capable of controlling it. if not, take all steps to isolate the area by closing Doors and Windows.

b) This Renewal of No Objection Certificate is valid for a period of Five (05) years from the Date of issue of this letter subject to the compliance of above Fire and Electrical Safety Measures. The Owner/ Occupier/ Builder/ Management concerned of the Building shall submit Self Declaration / Certification with regard to working condition of above Fire Safety System every year in the prescribed format and submit/upload the photographs of the Mock Drills conducted in the premises. It is the responsibility of the Builder to maintain the Fire Safety Equipments in good working condition at all times and apply for next Periodical Renewal of No Objection Certificate, duly remitting the User Charges vide G.O.Ms.No.90, Home (Prisons & Fire Services) Department Dated:13.08.2021 & G.O.Ms.No.120 (Prisons & Fire Services) Department Dated:25.10.2021, two (02) months before expiry of this Renewal of No Objection Certificate.
